the norms of the Directorate of Education, Delhi in each class. Number of the existing sections should not exceed the number of the class rooms of proper size in the school.

- 9. That the scheme of management shall be got approved from the department, if not done so.
- 10. That the school shall dispense with the services of unqualified and overaged staff, if any, immediately.
- 11. That the services contract between the management and the exployees shall be executed immediately.
- 12. That all the facilities prescribed under Rules 50 and 51 of the DSER, 1973 shall be made available to the students. Provisions of Rules 6,7 and 9 be strictly observed.
- That the arrangement of good drinking water shall be made available to all the students as well as the teachers and sanitary facilities shalllalso be provided to the students adequately. Health Certificate may be obtained from the Local Body within a month.
